A RESOLUTION

Approving and adopting the Federated States of Micronesia Strategic Development Plan 2024-2043.

1 WHEREAS, the first Federated States of Micronesia (FSM)
2 Strategic Development Plan (SDP) 2004-2023 expired in the year
3 2023; and

4 WHEREAS, the FSM National Government, through consultations
5 with all relevant stakeholders across all sectors, including
6 governments, private industry and civil society, formulated the
7 FSM's second Strategic Development Plan (SWDP) 2024-2043; and

8 WHEREAS, the 2024-2043 SDP includes a Monitoring,
9 Evaluation and Learning (MEL) framework to track progress,
10 ensure accountability, and enable adoptive management during
11 implementation; and

12 WHEREAS, the 2024-2043 SDP has received nationwide support
13 through its adoption by the 14th State and National Leadership
14 Conference (SNLC) held in Palikir from December 10-11, 2024; and

15 WHEREAS, the 2024-2043 SDP is an essential tool for the
16 nation as it provides a comprehensive framework for the
17 nation's sustainable development and addresses pressing
18 economic, social and environmental challenges; now, therefore,


